WHAT'S NEW

"Invasive Species of the Month" - July

The goal of Rutgers Cooperative Extension's "Invasive Species of the Month" is to highlight those organisms that are non-native to New Jersey and cause economic or environmental harm, or harm to human health. We can all help prevent the spread of invasives by learning which species are a threat to our ecosystems.

Silver Grass (*Miscanthus sinensis*)

Chinese silver grass (*Miscanthus sinensis*) is a popular ornamental plant that has spread from yards and commercial landscapes and is being found in increased numbers invading meadows, roadsides, utility rights-of-ways and other open areas in New Jersey. One or two clumps soon multiply and when not controlled, can push out native plants that are critical for wildlife.

2023 Spotted Lanternfly Tracking Survey (psu.edu)

The Penn State Extension Grape and Wine Team is calling on those who own, operate, or manage a farm or vineyard in the Mid-Atlantic region to participate in a survey that aims to track the spread and severity of nymph and adult spotted lanternfly populations during the 2023 season.

FUNDING OPPORTUNITIES

[SNAP Online Grant](#)

MarketLink is offering a grant to help direct-marketing farmers accept SNAP benefits online. The grant will cover all SNAP online transactions through GrownBy and WorldPay during the first year, as well as technical assistance with the USDA SNAP retailer authorization, training support, and ongoing maintenance.

[Farm Credit East AgEnhancement Grants](#)

Each year, Farm Credit East and CoBank award grants from \$500 to \$10,000 to help organizations promote awareness and strengthen agriculture, commercial fishing, and forest products in the six New England states, New York, and New Jersey. Applications are considered three times per year. The next cutoff date is August 1, 2023.

[Deer Fencing Grants for Unpreserved Farms](#). Unpreserved farm owners or operators in New Jersey may receive up to 50 percent matching funds (\$20,000 maximum, no more than \$200 per acre) from NJDA.

[Organic Certification Cost Share Program](#) (OCCSP). Certified operations may receive up to 75 percent of their certification costs paid during the program year, not to exceed \$750 per certification scope.

[Farm and Ranch Stress Assistance Network \(FRSAN\)](#).
